# 7 Habits of Highly Effective People

As 2015 comes to an end and we start looking forward to the possibilities of 2016, it seems like a good time to reflect on Stephen Covey's "7 Habits of Highly Effective People." This was his all-time best-selling book, which sold 25 million copies throughout the world. Covey was recognized as one of Time magazine's 25 most influential Americans, and was one of the world's foremost leadership authorities, organizational experts, and thought leaders.

Here is a summary of Stephen's 7 Habits as taken from an article in the Business Insider...

**Be Proactive.** As human beings, we are responsible for our own lives. We have the independent will to make our own choices and decisions, and the responsibility ("the ability to respond") to make the right choices. You have the freedom to choose your own fate and path, so having the independent will, imagination and self-awareness to make the right move makes you a proactive, and not a reactive, person.

Begin With The End In Mind. Mental visualization is extremely important. Covey says that all things are created twice: first, the mental conceptualization and visualization and a second physical, actual creation. Becoming your own creator means to plan and visualize what you're going to do and what you're setting out to accomplish and then go out and creating it. Identifying your personal statement and your principles will help.

**Put First Things First.** With your power of independent will, you can create the ending you want to have. Part of that comes with effective time management, starting with matters of importance. Then tasks should be completed based on urgency after you deal with all the important matters. If you deal with crises, pressing problems and deadline-driven projects first, your life will be a lot easier.

**Think Win/Win.** If you believe in a better way to accomplish goals that's mu continued on page 5

#### WASHINGTON REPORT

Just when you thought it was safe to go out. Conventional wisdom of most pundits has been that sectors concerned about

possible tax reform have nothing to worry about until after the presidential election. The year 2016 can be used to shore up positions and political ties and gear up for a big fight in 2017. But, then new House Speaker Paul Ryan announced that he would like the House to pass tax reform in the first half of 2016. His remarks were followed by new Ways And Means Chairman Kevin Brady of Texas echoing similar sentiments.

It's unclear where such 2016 tax reform will focus. There is the corporate sector, where there is great interest in a package that will lower and simplify corporate tax rates while restricting so-called inversions in which US companies through acquisitions place themselves under lower European tax rates. Or, will the package include broader tax reform which could include municipal bonds and the charitable deduction? We don't know but this means the communications you are planning to make in 2016 which might have slipped a few months perhaps should be accelerated into the beginning of the year. Obviously, we will monitor this closely.

We continue to build our coalitions and networking. The Bond Dealers of America (BDA) CEO spoke at our last meeting, and I had an opportunity to speak at theirs. In addition, I've been added to the BDA coalition working group on private activity bonds. The bond lawyers association, NABL, has invited me to meet with them when they come to Washington in January and we continue our close alliance with the Public Finance Network of governmental issuers as well as our close friends at AHA and NACUBO.

In other activities, we are working with coalitions to attempt to stop or mitigate actions which would potentially significantly impact market interest in our bonds. First, we are working with GFOA and other groups to promote legislation to reverse Federal Reserve rules which have excluded almost all municipal bonds from being considered high quality liquid assets or HQLA. Federal rules approved in September 2014 aim to ensure that big banks will be able to access enough cash during the financial crisis. But the rules excluded virtually all municipal bonds from the preferred types of securities. The fear is that the exclusion would deter banks from buying muni debt.

Second, SEC regulation of money market funds requires that MMF's be offered only with a "floating NAV," a price based upon estimates of the market based valuation of a funds underlying portfolio securities rather than the traditional fixed NAV. It is estimated that this requirement will have significant implications on investors' interest in such funds and therefore on funds' purchase of tax exempt bonds. We are working with large funds as well as GFOA on legislation to address these issues.

Our association had an active advocacy program in 2015, communicated important messages to Congress and the Administration, and built networks for future activities. The year 2016 will be equally active and then we will head into the Battle Royale on tax reform in 2017.

Please have great holidays and a happy new year. I look forward to seeing you next year. ■

tually beneficial to all sides, that's a win/win situation. "All parties feel good about the decision and feel committed to the action plan," Covey wrote. "One person's success is not achieved at the expense or exclusion of the success of others." If you have integrity and maturity, there's no reason win/win situations can't happen all the time.

**Seek First To Understand, Then To Be Understood.** If you're a good listener and you take the time to understand a concept, it will help you convey your opinions, plans and goals to others. It starts with communication and strong listening skills, followed by diagnosing the situation and then communicating your solution to others.

**Synergize.** Synergistic communication, according to Covey, is "opening your mind and heart to new possibilities, new alternatives, new options." This applies to the classroom, the business world and wherever you could apply openness and communication. It's all about building cooperation and trust.

**Sharpen The Saw.** Sometimes you're working so hard on the other six habits that you forget about re-energizing and renewing yourself to sharpen yourself for the tasks in front of you. Some sharpening techniques include exercise and nutrition, reading, planning and writing, service and empathy and commitment, study and meditation.
